 - This fourth supplemental public notice is being issued as a reminder of the January 21st public hearing to take oral comments and to make a correction to the public comment period end date, which is Friday, January 24, 2014.

Brief Description

- The Alaska Department of Environmental Conservation (DEC) is proposing to adopt new air quality regulations for the Fairbanks North Star Borough (FNSB) fine particulate matter (PM-2.5) non-attainment area. All the regulation changes are required in order to comply with provisions of the federal Clean Air Act, which is mandatory for every state. The proposed regulations establish federally required air episode levels for PM-2.5; establish emission standards for wood stoves and other wood heating devices and include restrictions on open burning. This third supplemental public notice is being issued to provide the public an opportunity to review and comment on peer review comments regarding DEC's regulations justification document called "The Need and Basis for More Stringent Wood-fired Heating Device Emission Standards in 18 AAC 50 Air Quality Control.
