The Department of Commerce, Community, and Economic Development proposes to adopt regulation changes in Title 3, Chapter 8,910, to comply with statutory language passed by the legislature under HB 308. Additionally the proposal will make changes to update the reference names of certain federal manuals that have changed. Language will also increase the notice time for rescission offers to 10 days from the current two days and provide definition language for “controlling person.” Other provisions will involve revisions language to correct outdated language.

The current regulations 03 AAC 26. 030-.300 relating to standards for the prompt, fair and equitable settlement of motor vehicle claims are outdated and difficult for insurers to comply with when trying to obtain sufficient information to determine the value of a vehicle that is a total loss. The revisions will address the use of electronic databases and other methods in addition to dealer quotes, while maintaining consumer protections. Additionally, similar changes will be made to the property settlement claims regulation to update the regulations to reflect the advancement of claims adjusting.

4 AAC 27 and 4 AAC 33 The regulations establish procedures for Charter schools to apply for pupil transportation and the process for an appeal if the local district does not accept the application the appeal can be reviewed all the way to the State Board.

Additional language requires charter schools to meet state and federal education standards and allows for inspection of those methods.

New Charter schools applying for a grant will have specific requirements and procedures for the application.

Department of Environmental Conservation

Contaminated Sites and Underground Storage Tanks

The Alaska Department of Environmental Conservation (DEC) is proposing to change regulations on contaminated sites and underground storage tanks to broaden the number of individuals who may qualify to conduct environmental work at contaminated sites and underground storage tank sites, adopt updates to referenced documents, and to clarify, simplify and make consistent additional regulatory language.

18 AAC 75.355 makes changes to permit “qualified samplers” to take tests when an environmental professional is not available. It further allows for a waiver of an impartial third party. Methods will be established using EPA standards.

18 AAC 75.365 changes language and definitions to comply with the EPA standards adopted.

18 AAC 78.007- .995 Similar changes are made it these sections to comply with EPA standards and the necessary language for qualified sampler and “qualified environmental professional.”

Also two DEC documents will be updated:

Underground Storage Tank Procedures Manual; and
Operation Requirements for Soil Treatment Facilities (previously titled the
Soil Treatment Facility Guidance).

DEPARTMENT OF NATURAL RESOURCES

The Department of Natural Resources proposes to adopt regulations to 11 AAC 05 that will provide for guidelines and fees for the use of state land proposed to be used for Wind Power Projects. The fees simply add wind power projects to existing land use fees with the exception of a one-time fee of \$1,500 per kilowatt produced and an annual rent based on 10% of fair market value. 11 AAC 05 is proposed to be changed to provide for new fees and rental rates for the use of state land associated with the use of state land for Wind Power Projects, and to make technical corrections to the departments fee regulations.
