

# Proposed Regulations as of November 6, 2014

## Board of Fish

1. The Alaska Board of Fisheries proposes to adopt regulation changes in Title 5 of the Alaska Administrative Code, dealing with fishery and aquatic plant resources in the Prince William Sound (including upper Copper River, upper Susitna River, Prince William sound saltwater, and Copper River district) finfish fisheries; southeast and Yakutat finfish fisheries; southeast and Yakutat crab, shrimp, and miscellaneous shellfish fisheries; and statewide dungeness crab, shrimp and miscellaneous shellfish fisheries. These changes effect Commercial, Subsistence, personal use, and Sport fishing.

Statewide includes specific drainages in the Kuskokwim, Yukon Rivers, Bristol Bay, Norton Sound, and the Gulf of Alaska.

Public Comment Period ends: Two weeks prior to the public hearing on each proposed fishery and area.(See Below) Written comments may also be hand delivered for each subject at the meeting if 28 copies are provided to the Board,
